

ORDINANCE 2015-06

AN ORDINANCE AMENDING THE ROAD AND BRIDGE FUND BUDGET OF THE TOWN OF LONGBOAT KEY, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2014, AND ENDING SEPTEMBER 30, 2015; TRANSFERRING FROM UNAPPROPRIATED FUND BALANCE TO PROFESSIONAL SERVICES-OTHER, CERTAIN FUNDS FOR A ROUNDABOUT FEASIBILITY STUDY; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Commission finds that it is the best interest of the health, safety and welfare of the public to consider the construction of roundabouts in the cross street areas of Longboat Club Road and at Gulf of Mexico Drive and at Broadway and Gulf of Mexico Drive; and

WHEREAS, the Town anticipates an estimated \$15,000.00 in expenditures related to a feasibility study of installing roundabouts at the cross streets of Longboat Club Road and Gulf of Mexico Drive and at Broadway and Gulf of Mexico Drive; and

WHEREAS, it is the desire of the Town to allocate certain gas tax revenue generated pursuant to Florida Statutes § 206.605 to fund such study; and

WHEREAS, the Finance Director certifies that sufficient unappropriated balances are available in the Road & Bridge Fund to make the required appropriations; and

WHEREAS, Article V, Section 9 of the Town Charter provides for such a supplemental appropriation;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF LONGBOAT KEY, FLORIDA, THAT:

SECTION 1. The above Whereas clauses are true and correct and are hereby ratified and confirmed.

SECTION 2. The Road & Bridge Fund budget of the Town of Longboat Key for the fiscal year beginning October 1, 2014, and ending September 30, 2015, as adopted pursuant to Ordinance 2014-28, is hereby amended to transfer Fifteen Thousand and 00/100 (\$15,000) from unappropriated fund balance to the following accounts:

SECTION 3. If any section, subsection, sentence, clause, or provision of this Ordinance is held invalid, the remainder of the Ordinance shall not be affected.

SECTION 4. All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

SECTION 5. This Ordinance shall take effect upon second reading and public hearing in accordance with Law and the Charter of the Town of Longboat Key.
