

- ___ Turf areas are planted in strips no narrower than 4 feet (except next to contiguous properties) Section 55.04(A)(5)
- ___ Irrigation system is installed for efficient and effective water use; Section 55.04(A)(6)
- ___ High and Low Irrigation Water Use Zones are operated independently; Section 55.04(A)(6)
- ___ Turfgrass areas, annual flowerbeds, and vegetable gardens are irrigated on separate zones from tree, shrub, and groundcover beds; Section 55.04(A)(6)
