Residents of the Town of Longboat Key must be registered to vote by Monday, August 1, 2016 to be eligible to vote on the Florida's referendum on August 30, 2016.

**The deadline to request an Absentee Ballot for this Election is today, August 24, 2016.**

**Vote by Mail (Absentee) Ballot Information:**

A voter, the voter's immediate family, or a legal guardian may request an absentee/vote by mail ballot in person, by mail, or by telephone. Effective Jan 1, 2014, a request for a ballot to be mailed to an address other than the one on file with the Supervisor of Elections must be in writing and signed by the voter. (Exception: absent uniformed service and overseas voters)
