The LLSA Chamber has requested Town Commission consideration to close Bay Isles Road between the hours of 8:30 – 11:30 AM for this year's July 4th parade along Bay Isles Road and associated activities in Bicentennial Park.

Town Code provisions require Town Commission authorization for temporary road closures.
