SUBJECT Commission Appointments to Committees Named in Town Code

At the May 7, 2012, Regular Workshop Meeting, the Town Commission formalized the appointments of Commissioners to committees named in the Town Code or as required by outside agencies.

At the time of his resignation, Commr. Lenobel was the Town's representative on the Criminal Justice Commission-City-County Corrections Work Group and also served as the alternate to Commr. Zunz as the Special Liaison to Manatee County.
