SUBJECT: 2014 Town Commission Meeting Schedule

At the October 21, 2013 Regular Workshop Meeting the Commission considered a proposed 2014 Town Commission Meeting schedule and requested additional information and options for the September meeting schedule. This memo includes options for Commission discussion at their November 4, 2013 Regular Meeting.

The attached 2014 Town Commission meeting schedule is being forwarded for Commission consideration. The schedule includes the proposed dates for Regular Meetings, Regular Workshop Meetings, the Statutory Meeting, Goals & Objectives Workshop, and Special Meeting to adopt the FY 2014-2015 Budget.

Currently the Town's General Municipal Election is scheduled for March 18, 2014 based on Town Code provisions. Anticipating the Town Commission establishing March 25, 2014 as the General Municipal Election date (to coincide with elections being hosted by Sarasota County School Board), the Statutory Meeting date would be held on March 31, 2014.

The proposed September Meeting schedule is driven by budget adoption requirements. Truth in Millage (TRIM) notices require there be no more than 20 days between first reading and second reading and adoption. Florida State Statutes require 10 days of published advertising for each public hearing. To comply with both, the Regular Meeting (first reading and public hearing for millage rate and budget) can be scheduled on either Tuesday, September 2; Wednesday, September 3; or Monday, September 8. The Special Meeting (second reading and public hearing for millage rate and budget adoption) is proposed for September 22, 2013 at 5:01 PM. The Regular Workshop Meeting would be held on the traditional third Monday (15th) which provides adequate time for advertising any items that may move forward to the October Regular Meeting. Please note that if the Commission elects September 8 for the Regular Meeting, items that may be requested for Workshop could not be scheduled until the October 20, 2013 Regular Workshop Meeting due to time constraints for material preparation.

The Town Code provides for Regular Meetings to be held on the first Monday of each month at 7:00 PM and for Regular Workshop Meetings to be held on the third Monday of each month. However, when the day fixed for Regular Meeting (or Regular Workshop Meeting) falls on a day designated by law as a legal holiday the meeting shall be held on another day as designated by the Town Commission. The Code provides latitude for Regular Workshop Meetings to be held on days other than the third Monday if deemed appropriate by the Commission. In November and December the Commission has elected to hold Workshop Meetings on the second Wednesday.

As you know, there will always be a need for unscheduled meetings such as Special Meetings, Budget Workshops, and Special Workshops. The attached calendar includes the Town Commission's customary meeting requirements that can be reasonably anticipated at this time as well as accommodating previously stated preference for 3 week breaks during November and December.

Town Charter, Article II

Section 6. Canvas of Returns; Certification of Election

Section 13. Meetings

Sec. 6. Hours polls to be open; canvass of returns; certification of election.

The polls shall be open at the voting places from 7:00 a.m. to 7:00 p.m., or as otherwise provided by law, on the same day, and the time shall be regulated by the customary time in standard use in the Town of Longboat Key on the date of the particular election. The result of the voting, when ascertained, shall be certified by the Supervisor of Elections or his deputy and delivered to the town clerk who shall transmit the returns to the town commission at a meeting to be held at 7:00 PM within three (3) business days following certification. At such meeting, the town commission shall canvass the returns and the result as shown by such returns shall be declared by the commission to be the result of the election. The town clerk shall thereupon furnish a certificate of election to each person shown to have been elected, and each such person shall take office at that meeting.

Sec. 13. Meetings.

- (a) At 7:00 p.m. pursuant to Article II, Section 6, of this Charter following each general municipal election, the town commission shall meet at the usual place for holding the meeting of the legislative body of the town, at which time the newly elected commissioners shall assume the duties of office. Thereafter the town commission shall meet at such times as may be prescribed by ordinance or resolution, except that it shall meet regularly not less than once each month for a regular voting meeting and once each month for a regular non-voting workshop, except that the regular non-voting workshops in the months of July and August and the regular monthly voting meeting in the month of August may be cancelled by the commission if cancelled at least thirty (30) days prior to the day on which the meeting would normally be conducted.

(D) Workshop Meetings

(B) *Regular meetings.* The town commission shall hold a regular monthly meeting on the first Monday of each month in the town chambers at 7:00 p.m. or at the time of day the commission may decide; however, when the day fixed for regular meetings falls on a day designated by law as a legal holiday, the meeting shall be held on another day as designated by the town commission.

(D) *Workshop meetings.* The town commission may meet in workshop for study and discussion of the affairs of the town in the commission chambers of the town hall, but no formal or binding action may be taken at these meetings. Unless the town commission shall determine otherwise, regular workshop meetings shall be held on the third Monday of each month at 1:00 p.m. However, when the day fixed for a regular workshop meeting falls on a day designated by law as a legal holiday, the meeting shall be held on another day as designated by the town commission. Special workshops may be scheduled as deemed necessary by the town commission.
