SUBJECT: Appointment to the Police Officers' Retirement System Board of Trustees

The Town Commission adopted Ordinance 2014-02 revising the membership categories for the seated Police Officers' Retirement System Board of Trustees consisting of five Commission appointed residents to the Board. Additionally, the Town Manager will have the authority to appoint two additional members. The Commission has established a procedure to hold Special Workshop Meetings to provide the opportunity for Town Commissioners to meet the applicants prior to formal appointments at the February 3, 2014, Regular Meeting.
