At the November 7, 2011 Regular Meeting the Town Commission agreed to continue the Town's support of this annual charitable fund raising event. It was brought before the Commission at that time because the format had changed somewhat from previous years. This year the event will take place on Saturday, December 6<sup>th</sup> at the Longboat Key Club and Resort at the Islandside Driving Range. Last year the proceeds of this annual Longboat Key Kiwanis Club event benefitted the following charities:
