SUBJECT: Ordinance 2015-16, Amending Chapter 33, Boards and Commissions

At the April 20, 2015 Regular Workshop Meeting the Town Commission considered the current composition of the Planning & Zoning (P&Z) Board and provided direction to staff to develop an Ordinance to reduce the number of members from nine (9) to seven (7).

Ordinance 2015-16, provides for a seven member P&Z Board, as well as for length of terms, term limits, and an effective date upon adoption at the May 18, 2015 Special Meeting.

The attached memorandum dated April 21, 2015 outlines the process for P&Z Board Appointments.

SUBJECT: Process for Planning & Zoning (P&Z) Board Appointments

At the April 20, 2015, Regular Workshop Meeting, the Town Commission directed Staff to proceed, as expeditiously as possible, to forward an ordinance (Ordinance 2015-16) to sunset the existing nine (9) member Planning & Zoning (P&Z) Board and establish a newly constituted Board with seven (7) members.

After reviewing legal advertising requirements, and considering available meeting opportunities, the following process and schedule has been established:

1. May 4, 2015, Regular Meeting at 7 p.m. – Town Commission’s first reading of Ordinance 2015-16, modifying the composition and term of the entire P&Z Board, and establishing term limits.
2. May 11, 2015, at 12:00 p.m. - Application deadline for persons interested in seeking consideration to serve on the P&Z Board.
3. May 12, 2015, by close of business - Materials for the May 19, 2015, Joint Meeting between the Town Commission and P&Z Board will be published and available to all Town Commissioners and P&Z Board applicants. Applicants for the P&Z Board are encouraged to obtain and review these materials.
4. May 18, 2015, Special Workshop Meeting at 11:00 a.m. (time certain) - The Town Commission will hold a Special Workshop Meeting for “Meet & Greet” for P&Z Board Applicants following the May 18, 2015, Special Workshop Meeting on the FY2016 Budget.
5. May 18, 2015, Special Meeting at 1:00 p.m. (time certain) - The Town Commission will hold a Special Meeting to certify the May 12, 2015, Referendum election results. The second reading and public hearing of Ordinance 2015-16 will occur, followed by the appointment of P&Z Board members. If Ordinance 2015-16 passes, the Town Commission will select seven (7) P&Z Board members. If Ordinance 2015-16 fails, then the Town Commission will select four (4) P&Z Board members to fill the open seats.
6. May 19, 2015, Joint Town Commission and P&Z Board Special Workshop Meeting at 9:00 a.m. - Town Commission and P&Z Board members will meet to discuss ongoing policies relating to Comprehensive Plan and

Land Development Code revisions. All newly appointed P&Z Board members will be expected to attend the Joint Town Commission/P&Z Board Special Workshop Meeting. Materials for the workshop will be provided in hard copy and available on the Town's website seven (7) days in advance of this meeting.

ORDINANCE 2015-16

AN ORDINANCE AMENDING CHAPTER 33, BOARDS AND COMMISSIONS, OF THE CODE OF ORDINANCES OF THE TOWN OF LONGBOAT KEY, FLORIDA; AMENDING SECTION 33.20, CREATION, MEMBERS; AMENDING SECTION 33.23, MEETINGS; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Article II, Section 20 of the Town Charter, the Town Commission shall establish by ordinance the duties, responsibilities, and terms of certain advisory board including the Town's Planning and Zoning Board ("Board"); and

WHEREAS, at a Town Commission workshop held on April 20, 2015, the Town Commission evaluated the membership composition of the Board and has determined it is in the best interest of the Town to reduce the number of members of the Board from nine to seven members and to establish term limits relating to member service on the Board; and

WHEREAS, the Town Commission desires to amend its Code of Ordinances to incorporate the membership and term limit changes provided for herein; and

WHEREAS, the Town Commission of the Town of Longboat Key finds that the reduction in members of the Board is in the best interest of the health, safety, and welfare of the citizens of Longboat Key.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF LONGBOAT KEY, FLORIDA, THAT:

SECTION 1. The Whereas clauses above are ratified and confirmed as true and correct.

SECTION 2. Chapter 33, Section 33.20, *Creation; members*, is hereby amended as follows:

(A) There is hereby created a planning and zoning board for the town, which shall consist of seven (7) ~~nine~~ members appointed by the town commission. The board shall elect a chairman annually from among its members. All members must be registered voters and residents of the Town of Longboat Key. All members must attend a sunshine and public records law class within three months of their appointment. No member shall be an elected official or employee of the town. A person appointed to this board may not serve concurrently on any of the following town boards: code enforcement board, ~~ethics commission~~, consolidated retirement system board of trustees, or zoning board of adjustment.

(B) Initial appointments to the seven (7) member board shall be as follows: two (2) members shall have a one-year term, two (2) members shall have a two-year term, and

three (3) members shall have a three-year term. Thereafter, all members ~~Members~~ shall be appointed for a period of three years. The terms of appointment shall expire on the second Wednesday of May of the year in which the term is set to expire. Any member who fails to attend three (3) consecutive scheduled and called regular meetings shall automatically forfeit his appointment, and the town commission shall promptly fill the vacancy. Vacancies shall be filled by appointment for unexpired terms only.

(C) No board member shall serve more than two (2) consecutive terms or a total of six (6) years as a member of the planning and zoning board without an interval of one (1) year out of office. After a one-year period of non-membership on the planning and zoning board, a person will again become eligible for re-appointment by the town commission. Term limits shall be prospective in application and shall be calculated after the effective date of Ordinance 2015-16.

SECTION 3. Chapter 33, Section 33.23, *Meetings*; Subsection (B) is hereby amended as follows:

(B) A quorum for any meeting of the board shall be ~~five~~ four (4) of the members. When less than a quorum is present at any meeting which has been duly called, those present may adjourn or recess the meeting to a future date to be specified in the motion of adjournment or recess.

SECTION 4. If any section, subsection, sentence, clause or provision of this Ordinance is held invalid, the remainder of the Ordinance shall not be affected.

SECTION 5. All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

SECTION 6. This Ordinance shall take effect upon second reading in accordance with Law and the Charter of the Town of Longboat Key.
