Agenda Item: Confirmation of Continued Support for 2016 Longboat Key
Kiwanis Club Lawn Party

Summary: The Town has supported the Longboat Key Kiwanis Club Lawn Party in the past by providing Public Works staff and small equipment for the annual charity fundraising event. This year's event will take place, as in the previous four years, at the Longboat Key Club Islandside Driving Range on Saturday, December 3, 2016.

Prior to its transition to the Longboat Key Kiwanis Club Lawn Party, the Town supported a similar Kiwanis event known as the St. Jude's Gourmet Luncheon almost 30 years.

SUBJECT: 2016 Longboat Key Lawn Party

At the November 7, 2011 Regular Meeting the Town Commission agreed to continue the Town's support of this annual charitable fund raising event.

It was brought before the Commission at that time because the format had changed somewhat from previous 25+ years from being known as the St. Jude's Luncheon (benefitting only St. Jude's Children's Research Hospital) to the Kiwanis Club Lawn Party benefitting many *local* non-profit children's organizations. Since that time, the Commission reaffirms annually, their continued support of this annual community event.

This year the event will take place on Saturday, December 3rd at the Longboat Key Club and Resort at the Islandside Driving Range. Last year the proceeds of this annual Longboat Key Kiwanis Club event benefitted the following children's charities:

The Town has traditionally assisted the Longboat Key Kiwanis Club organizers by providing limited staffing of Public Works employees assisting with the delivery and set-up of tents and small generators. We also store in Town facilities the 66 +/- tents year round that are utilized for this one-day event. The estimated cost for the personnel and equipment associated with this event is \$2,400.

This item is placed on the October 17, 2016 Regular Workshop Consent Agenda to reaffirm Town Commission approval for the Town's continued support of this annual event. If approved on Consent, this item will be placed on the November 4, 2016 Regular Meeting Consent Agenda for formal action.
