**CALL TO ORDER**

Mayor Spoll called the Special Meeting of the Longboat Key Town Commission to order at 5:53 p.m., in the Town Commission Chamber, 501 Bay Isles Road, Longboat Key, Florida.

**1. Appointment to Fill a Vacancy on the Planning and Zoning (P&Z) Board; Seat 4**

Due to the resignation of John Redgrave a vacancy exists on the P&Z Board. This item is placed on the March 25, 2010 Special Meeting for appointment to Seat 4 with a term expiration of May 11, 2011. Recommended Action: Pending discussion, appoint individual to Seat 4 on the P&Z Board.

**Following comments on consideration of the appointment, Commr. Siekmann moved to consider the appointment for Seat 4 on the P&Z Board. The motion was seconded by Commr. Lenobel. Following comments, the motion carried unanimously on voice vote.**

Town Clerk Trish Granger noted that all previous applicants on file had been contacted and that Ms. Rosemary Dilgard, Mr. Chuck Nechem, and Mr. Woody Wolverton had not responded prior to the deadline for the agenda to be distributed. Town Clerk Granger advised that Mr. Wolverton had responded on March 24, 2010, requesting his application be distributed and considered for this appointment.

Following comments from Town Manager Bruce St. Denis regarding Mr. Wolverton's application, Town Clerk Granger polled the Commission for the vacated seat on the Planning and Zoning Board, as follows:

**Commr. Siekmann modified his vote and cast a vote for Mr. Bradford Saivetz.**

**Town Clerk Granger noted the appointment of Mr. Bradford Saivetz to Seat 4 with a majority of four votes and advised that Mr. Saivetz would receive formal notification in accordance with established procedures.**
