PLEASE BE ADVISED THAT THE FLORIDA GOVERNOR'S OFFICE PURSUANT TO EXECUTIVE ORDER 20-52 DECLARED A STATE OF EMERGENCY FOR THE ENTIRE STATE OF FLORIDA DUE TO THE NOVEL CORONAVIRUS DISEASE (COVID-19) AND HAS EXTENDED IT THEREAFTER MOST RECENTLY PER EXECUTIVE ORDER 20-276. #### Virtual Public Participation Instructions and Process

A physical quorum of the Town of Longboat Key Consolidated Retirement System Board of Trustees ("Board") will gather in-person for a Town of Longboat Key Consolidated Retirement System Board of Trustees meeting on November 18, 2020. within the Town Commission Chambers at Town Hall, 501 Bay Isles Road, Longboat Key, Florida, and other members of the Board may appear and utilize communication media technology ("CMT"), specifically Ringcentral, to participate in the public meeting. The Town will conduct the public meeting in-person and virtually using CMT as indicated in the CMT instructions below. The public will also be permitted to attend the meeting/hearings inperson. In-person gatherings by the public at Town Hall shall be governed by applicable Gubernatorial Executive Orders in effect at the time, CDC and Health Department recommendations, Town Emergency Ordinance 2020-21, and the Town Manager's Emergency Executive Orders. The Town will require that all persons attending the public meeting/hearings within Town Hall observe and follow applicable CDC and Health Department guidelines on social distancing and public gathering size limitations. The public must also observe the face covering requirements set forth in Emergency Ordinance 2020-21 within Town Hall.

The Town encourages public participation and is providing multiple options for the public to participate in the proceedings in a manner that accommodates individual needs and health concerns. Irrespective of whether the Town's meeting and public hearing is held virtually or whether an in person meeting of the Town of Longboat Key Consolidated Retirement System Board of Trustees is held at Town Hall, or a combination of in-person and virtually, members of the public may choose to appear and utilize Communication Media Technology as described below during the public hearings.

Time limits will be enforced for written comments that are read into the record, so all written comments must be limited to 3 minutes.
