### **Recommended Action**

### **Background**

Due to term expirations and vacancies on the Planning & Zoning (P&Z) Board, the Zoning Board of Adjustment (ZBA), and the Citizens Tax Oversight Committee (CTOC), the Commission will hold several individual Meet and Greets on April 5, 2020, providing an opportunity to meet the applicants who have applied for the seats.
