**SUBJECT:** Request for Town Commission Consent to the Designation of Attorney

Article VI (Sec. 2) of the Town Charter provides that the Town Attorney may appoint qualified Assistant Town Attorneys with the advice and consent of the Town Commission. Earlier this year, attorney Andrew Mai joined the law firm of Persson, Cohen & Mooney. Mr. Mai has over 20 years of legal experience in local government law. He has served as a County Attorney for Osceola County and a City Attorney for Sioux City, Iowa.
