# 9. Adjournment

Please be advised that the Florida Governor's Office has declared a State of Emergency due to the Coronavirus (COVID-19) pandemic. As reported by the Center for Disease Control and World Health Organization, COVID-19 can spread from person-to-person through small droplets from the nose or mouth, including when an individual coughs or sneezes. These droplets may land on objects and surfaces. Other people may contract COVID-19 by touching these objects or surfaces, then touching their eyes, nose or mouth. Therefore, merely cleaning facilities, while extremely important and vital in this crisis, may not be enough to stop the spread of this virus. Those with weakened immune systems may want to avoid the Special Magistrate Hearing in order to avoid a potential exposure to the virus.

A Special Magistrate Hearing will gather in person within the Town Commission Chambers at Town Hall, 501 Bay Isles Road, Longboat Key, Florida, and other members of the hearing may appear and utilize CMT (Communication Media Technology) during the declared State of Emergency, specifically Zoom, to expand participation in the hearings. In person gatherings by the public at Town Hall shall be governed by applicable Gubernatorial Executive Orders in effect at the time, CDC and Health Department recommendations. The Town will require that all persons attending the public meeting/hearing within Town Hall observe and follow applicable CDC and Health Department guidelines on social distancing. The public must also observe any applicable health, safety and welfare protocols within Town Hall.

While it is necessary to hold the above referenced hearing of the Special Magistrate despite the current public health emergency, the Town staff fully encourages public participation in a safe and efficient manner.
