B. Resolution 2021-10, Adopting the Town of Longboat Key RY 2021-2022 (FY22) Budget

5. Ordinance – First Reading and Public Hearing

Ordinance 2021-05, Amending the Capital Improvements Schedule of the Capital Improvements Element Concurrent with Adoption of the FY 2021-2022 (FY22) Budget.

Ordinance 2021-05 concurrently updates the five-year Capital Improvement Schedule of the Capital Improvements Element with adoption on the FY22 Budget as required by Florida Statutes.

Recommended Action: Forward Ordinance 2021-05 to September 27, 2021, Special Meeting for second reading, public hearing, and adoption.
