5. Discussion Items

A. Proposed Ordinance 2021-13, Sound Regulations; and Follow-up Regarding Noise, Signage, and Enforcement Issues

At the June 21, 2021 Regular Workshop Meeting the Commission directed staff to follow up on a series of issues affecting the North end of the island around Greer Island and Jewfish Key. An update on staff and Town Attorney efforts regarding those issues will be provided. One of the follow-up items included updating the Town's existing Noise Ordinance. A proposed update will be presented by the staff and Town Attorney for Commission consideration.

Recommended Action: Provide direction to Manager, and forward Ordinance 2021-13 to the November 1, 2021 Regular Meeting for first reading.

B. Update Regarding Multi-Story Structures Safety and Recertification

Following the tragic building collapse in Surfside, FL, Town staff initiated outreach to multi-story condominium properties encouraging assessments of the structural integrity of older, multi-story buildings to ensure the safety of residents and visitors. The staff will provide an update regarding current legislative efforts and continued follow-up with representatives of local multi-story structures.

Recommended Action: None, informational only.

C. Beach Management Plan Projects Update

Following completion of the 2021 beach projects and North end groins construction, Town staff will discuss the 2021 beach projects closeout and next steps including the Canal 1A Spit Management Plan and tightening of the New Pass groin structure.

D. Virtual Meeting Options for Advisory Boards

At their June 7, 2021 Regular Meeting the Town Commission passed Resolution 2021-15, which provides for allowing Commissioners virtual participation at meetings under approved situations, and contingent on a physical quorum being present at Town Hall. The Planning & Zoning Board requested consideration for similar provisions to apply to Advisory Board meetings. The Commission requested that this discussion be scheduled in the Fall.
