#### 5. Consent Agenda

The purpose of the Consent Agenda is to expedite formal action on agenda items that are routine in nature. Recommended Action: Approve Minutes.

B. Approval of Interlocal Agreement for Joint County/Municipality Economic Development Program

In 2005 the cities of North Port, Sarasota, Venice and the Town of Longboat Key entered into an agreement for administration of a joint economic development program. Each are represented on the Economic Development Corporation of Sarasota County by a member of each respective Commission. This updated agreement has been reviewed by the County and all municipalities and is being presented to each body for approval.

Recommended Action: Authorize the mayor to execute Interlocal Agreement for Joint County/Municipality Economic Development Program.

C. Public Forum Permit (PFP) Application Requests for Waiver of Permit Fee

The Hermitage Artist Retreat at the Town Center Open Venue on February 25, 2022; and Christ Church observance of National Prayer Day on May 5, 2022.

Recommended Action: Waive the \$100 PFP application fee.

# 6. Ordinance - Second Reading & Public Hearing

A. Ordinance 2022-01, Amending Chapter 96, Health and Sanitation, Gas Fire Pits Outside Structures

Over the past year, multiple developers have requested permits to install gas fire pits outside of structures (i.e. yards, patios, pool decks). Currently permitting for propane and natural gas pits (open fires) are not provided for in our Code. Ordinance 2022-01 would provide for a permitting, and inspection process for permanently installed fire pits consistent with language in the National Fire Code and Florida Statewide Building Code. This item was forwarded from the January 10, 2022 Regular Meeting following first reading.

Recommended Action: Adopt Ordinance 2022-01.

B. Ordinance 2022-02, Amending Chapter 158, Zoning Code, Final Approval Authority for Freestanding Personal Wireless Service Facilities

The Town Commission directed staff to bring forward Ordinance 2022-02 to establish the Commission as final approval authority for freestanding personal wireless facilities due to the Town-wide applicability, and high priority in the Commission's strategic planning. This item was forwarded from the January 24, 2022 Special Meeting following first reading and public hearing.

Recommended Action: Adopt Ordinance 2022-02.

#### 7. Resolution

Resolution 2022-01, Supporting Sarasota County Infrastructure Surtax Phase IV, and Establishing Project List

Sarasota County has a referendum question on the upcoming ballot for continuation of a 1% discretionary sales tax (surtax) and is planning for implementation of Phase IV should the referendum be successful. The municipalities are asked to submit categories and planned projects for this 15-year projected revenue stream. Resolution 2022-01 is placed on the February 7, 2022 Regular Meeting for formal action to meet the County deadline for the Town's project list.

Recommended Action: Pass Resolution 2022-01.
