At their November 15, 2021 Regular Workshop Meeting the Town Commission received an initial update on the Complete Streets Corridor Plan process for Gulf of Mexico Drive. A Gulf of

Mexico Drive Complete Streets Corridor Master Plan will include strategies for the full 10-mile State of Florida roadway corridor, including the bike lanes and sidewalk. Town staff continues to work with Kimley-Horn & Associates to advance the planning effort based on previous input. They have prepared this status report to update the Commission on the current efforts and receive additional feedback at this stage of the process.
