5. Consent Agenda

The purpose of the Consent Agenda is to expedite formal action on agenda items that are routine in nature. Any item on the Consent Agenda can be removed from the Consent Agenda and placed on the Regular Meeting Agenda by any member of the Commission without a motion, a second, or a vote. Otherwise, all items on the Consent Agenda are voted upon in their totality by one action (motion, second and vote) and are not subject to discussion. B. Resolution 2022-09, Providing for Joint Meeting with Manatee County Commission

Each year the Town Commission meets jointly with the Manatee County Commission. This year the meeting is scheduled for May 26, 2022 beginning at 1:30pm at the Manatee County Government Administration Center, Fourth Floor, Manatee Room, 1112 Manatee Avenue West, Bradenton, FL. Resolution 2022-09, provides authority for this meeting to be held.

Recommended Action: Pass Resolution 2022-09.

6. Ordinance - Second Reading and Public Hearing

A. Ordinance 2022-09, Amending Chapter 72, Parking

A provision in the Town Code provides for the ability to reduce the amount of a parking citation penalty when reviewed by the Police Department. Ordinance 2022-09 was drafted for Commission consideration in order to eliminate that provision and consistently manage the appeals process for parking citations through the Special Magistrate. Ordinance 2022-09 was forwarded from the April 4, 2022 Regular Meeting for second reading and public hearing.

Recommended Action: Adopt Ordinance 2022-09.

B. Ordinance 2022-04, Amending the Comprehensive Plan Future Land Use Map for 597 Buttonwood Drive

Ordinance 2022-04 is an amendment to the Comprehensive Plan's Future Land Use Map from OI, Office Institutional to RM-3, Medium Density Single-Family Residential of 3 units per acre designation which allows for less density and intensity usage. This item was forwarded from the April 4, 2022 Regular Meeting for second reading and public hearing.

Recommended Action: Adopt Ordinance 2022-04.

7. Quasi-Judicial Ordinance - Second Reading & Public Hearing

Ordinance 2022-05, Zoning Map Amendment (Rezoning) Application for 597 Buttonwood Drive

Ordinance 2022-05 is a request for rezoning the property to the R-3SF Zoning District from the current OI Zoning District, which would enable the applicant to move forward with subdividing the property for construction of two detached single-family homes. This item was forwarded from the April 4, 2022 Regular Meeting for second reading and public hearing.

Recommended Action: Adopt Ordinance 2022-05.

Resolution 2022-08, Amending the FY22 Budget in the Amount of \$123,000 in Miscellaneous Grant Fund for Dog Park Improvements

A grant received from the Rotary Club of Longboat Key for improvements to the Bayfront Park Dog Park requires a budget amendment to the FY22 Budget. Resolution 2022-08 will enable staff to accept the grant and fund the improvements.

Recommended Action: Pass Resolution 2022-08.
