## Background

Due to term expirations and vacancies on the Planning & Zoning Board, Zoning Board of Adjustment, Citizens Tax Oversight Committee, Metropolitan Planning Organization (MPO) Citizens Advisory Network, Sarasota County Bicycle/Pedestrian/Trail Advisory Committee, and the Citizens' Oversight Committee for Public School Facility Planning, the Clerk's Office has advertised for interested applicants. Each Advisory Board or Committee is listed below the information regarding vacancies and the current applicants and/or incumbents interested in being reappointed.

**The Planning & Zoning (P&Z) Board** has two seats open due to term expirations for appointment/reappointment for full three-year terms. The following individuals submitted applications for consideration:

**The MPO Citizens Advisory Network** has a vacant seat for a Longboat Key representative. Mr. Eddie Abrams and Mr. John Rayis have submitted their applications for consideration to serve as the Longboat Key representative.

Citizens' Oversight Committee for Public School Facility Planning has a vacant seat for a Longboat Key representative. There were no applications submitted by the deadline.
