#### 5. Discussion Items

A. Gulf of Mexico Drive (GMD) Complete Streets Corridor Plan Update

The Town Commission considered GMD Complete Streets Corridor Plan at the November 15, 2021, and March 21, 2022 Regular Workshop Meetings. Staff, along with Kimley Horn and Associates will provide an update, recommendations, and next steps at the September 27, 2022 Regular Workshop Meeting.

Recommended Action: Provide direction to Manager.

B. Proposed Ordinance 2022-13, Establishing Chapter 115, Residential Rental Registry Requirements and Program

At the June 21, 2022 Regular Meeting staff was directed to streamline the proposed rental registry program to include regulations necessary to ensure vacation rentals (those of less than 6 months) were compliant with existing State and Town regulations, and provided proactive measures to address impacts related to vacation rentals in neighborhoods.

Recommended Action: Forward Ordinance 2022-13 to the November 7, 2022 Regular Meeting for first reading.

C. Proposed Ordinance 2022-16, Amending Chapter 130, Sound Regulations

On January 10, 2022 the Town Commission adopted Ordinance 2021-13, which updated Chapter 130.02 of the Town's Sound Regulations. In implementation of the new Code, staff has identified four additional recommendations for sound subject to exemption provisions and a clarification related to an existing exemption.

Recommended Action: Forward Ordinance 2022-16 to the November 7, 2022 Regular Meeting.

D. Recommendations for Amending the Town's Comprehensive Plan, Infrastructure (Batch 3)

The Town Commission will consider Planning and Zoning (P&Z) Board recommended changes to the Infrastructure Element of the Comprehensive Plan. This is Batch 3 of a series of updates recommended as part of the Evaluation and Appraisal Report review that occurred in 2021.

Recommended Action: Accept P&Z Board recommendations, and proceed with a formal ordinance to be considered by the P&Z Board prior to scheduling first reading by Town Commission.

E. Utilities Undergrounding Update

On a quarterly basis at Regular Workshop Meetings, the Town Manager and staff provide an update on various components on the Utilities Undergrounding Project
