### **Recommended Action**

Meet applicants seeking appointment to the Planning and Zoning Board and Zoning Board of Adjustment.

### **Background**

Due to two term expirations on the Consolidated Retirement System Board of Trustees, a vacancy on the Planning and Zoning Board, a vacancy on the Zoning Board of Adjustment, and one vacancy on the Citizens' Oversight Committee for Public School Facilities Planning, the Commission will hold several individual Meet and Greets on November 7, 2022, providing an opportunity to meet the applicants who have applied for the seats.

Mr. Frank Cona (District 3) and Mr. Andrew Sawyer (District 5) are current members of the Consolidated Retirement System Board of Trustees whose terms are expiring and are interested in continuing to service in their current positions. Due to the two applicants being incumbents, Meet and Greets were not scheduled for Mr. Cona and Mr. Sawyer.

The Planning and Zoning Board has on vacancy for a partial term until May 14, 2025. The following individuals submitted applications for consideration:

- Mr. Steven Berling, District 1
- Dr. Ronald Ginsberg, District 2.

The Zoning Board of Adjustment has one vacancy for a partial term until May 10, 2023. The following individuals submitted applications for consideration:

- Mr. Eddie Abrams, District 5, (Currently serving as the representative on the Metropolitan Planning Organization Citizens' Advisory Network)
- Mr. Steven Berling, District 1
- Mr. Philip Deming, District 2
- Dr. Ronald Ginsberg, District 2.

The Citizens' Oversight Committee for Public School Facility Planning has a vacant seat for a Longboat Key representative. There were no applications submitted by the deadline. We will continue to advertise the opening on the Citizens' Oversight Committee for Public School Facility Planning.

Commission appointments are to be made as part of the 1 p.m. Regular Meeting agenda. The Consolidated Retirement System Board of Trustees, Planning and Zoning Board, and the Zoning Board of Adjustment next meetings are scheduled

in November and the appointees will be able to participate in the upcoming meetings.
