Recommended Action

Background

Pursuant to Resolution 2018-07, each year, the Town Commission considers appointments of Commissioners to committees named in the Town Code or as required by outside agencies. Attached is a list of the 2018 appointments.

Former Commissioner Brown served as the Town's alternate on the Economic Development Corporation of Sarasota County and the ManaSota League of Cities. Those vacancies will need to be filled by a seated Commissioner. He was also the Town's representative on the Water Alliance Board

In researching the history of the Water Alliance Board, Mr. Patrick Lehman, Executive Director of the Peace River ManaSota Regional Water Supply Authority, has advised the Water Alliance Board is no longer active. Mr. Lehman indicated that they would not be reconvening it and if a meeting is required, they would schedule a regional water forum and invite the jurisdictions for that specific meeting, so an appointment to this Board is not required and it has been removed from the appointment list.
