#### 5. Discussion Items

A. Sea Level Rise & Resiliency Comprehensive Adaptation Plan – Phase 4 Update

In 2018 the Town engaged APTIM Environmental & Infrastructure to provide a practical, high level overview of impacts from sea level rise and recurrent flooding, and then to develop recommendations for adaptation. Since that time the Town has completed Phase 1 Initial Assessment, Phase 2 Define Impacts, and Phase 3 Adaptation Strategies. The Phase 4 Comprehensive Adaptation Plan will function as a road map for future Capital Improvement Plan operations planning, pursuit of grant funding, as well as a guidance document for future development of Town Code amendments as needed.

Recommended Action: None, informational only.

B. Canal Navigation Maintenance Program Update

At the March 22, 2021, Regular Workshop Meeting staff outlined a Navigation Maintenance Program Management approach, and highlighted various funding options for the program with consensus provided to hire a consultant to move the program forward. Taylor Engineering and its subcontractor, Government Services Group, will present results of tasks performed to date and the path forward for developing and implementing the program.

Recommended Action: None, informational only.

#### C. Broadway Street Traffic Calming

Town staff has worked with the Village Traffic Calming Committee to address their concerns with traffic along Broadway Street. Our consultant Kimley-Horn and Associates, Inc., was hired to review roadway characteristics and develop traffic calming options with rough order of magnitude costs. The Town Commission is being asked to consider options developed and provide direction to staff.

Recommended Action: Provide direction to Manager.

#### D. Green (Environmental) Initiatives Update

Following the October 18, 2021, Town Commission Strategic Planning Retreat, staff developed an internal group to coordinate, facilitate, and report on actions being taken in support of "Green (Environmental) Initiatives." This update is the third provided to the Commission and includes more recent Green Initiatives actions taken, and categories of: Recently Completed; Active, Planned or Ongoing Initiatives; and Previously Completed Initiatives.

Recommended Action: None, informational only.
