## 5. Consent Agenda

Otherwise, all items on the Consent Agenda are voted upon in their totality by one action (motion, second, and vote) and are not subject to discussion. A vote in the affirmative on the Consent Agenda provides the formal action noted for each item.

#### A. Approval of Minutes

June 5, 2023, Regular Meeting; June 20, 2023, Special Workshop (Budget). Recommended Action: Approve Minutes. B. Lease Agreement with A.T.&T.

To approve and authorize the Town Manager to execute a lease agreement with New Cingular Wireless PCS, LLC, by AT&T Mobility Corporation, it's Manager for use of the Town's streetlight poles for small cell devices to enhance their wireless coverage on the Island.

Recommended Action: Approve and authorize the Town Manager to execute the lease agreement.

C. Amendment to Consolidated Retirement System Investment Policy

The Town's Financial Advisor, Graystone Consulting, recommended to the Consolidated Retirement System Board of Trustees a minor change to the Investment Policy Statement at their regular quarterly meeting held May 19, 2023. The Board of Trustees concurred with the change which requires Commission action to amend the Consolidated Retirement System Investment Policy.

Recommended Action: Approve Amendment to Consolidated Retirement System Investment Policy.

D. Amendment to the 2023 Adopted Commission Meeting Schedule

To approve amendments to the adopted 2023 Commission Meeting Schedule to delete the September 11, 2023, Special Workshop (Budget); incorporate a Special Meeting on September 18, 2023; cancel the October 16, 2023, Town Commission Retreat; and reclassify the November 13, 2023, Regular Workshop as the Retreat.

Recommended Action: Approve the amendment to the adopted Meeting Schedule.

E. Resolution 2023-23, Adoption of the Revised 2021 Sarasota County Floodplain Management Plan (FMP)

In March 2021, the Town Commission passed Resolution 2021-05, formally adopting the revised Sarasota and Manatee County Local Mitigation Strategies (LMS) under an agreement with the Department of Community Affairs. An annex to the LMS is the Sarasota County Floodplain Management Plan (FMP), which also requires formal adoption by the Town Commission to make the Adopted Local Mitigation Strategy current.

Recommended Action: Pass Resolution 2023-23.

B. Resolution 2023-22, Fiscal Year 2022-2023 (FY23) Budget Amendment

Public hearing to consider Resolution 2023-22 to amend the FY23 Budget adopted Budget and Five-Year Capital Plan for FY23-27.

Recommended Action: Pass Resolution 2023-22 following public hearing.

Setting of Maximum Millage Rate

In accordance with Florida Statutes, the Town must establish a proposed maximum millage rate by July so that it can be included in the Notice of Proposed Property Taxes mailed in August by each County. Although it can be reduced in later public hearings, these millage rates cannot be increased during future consideration of the budget.

Recommended Action: Set Maximum Millage Rates and forward required documents to adopt millage rates and Budget, based on these tentative rates, to the September 11, 2023, Special Meeting, at 5:01 p.m., for first public hearing.
