Subject: Ordinance 2023-12, Establishing the 2024 Election Dates

Recommended Action

Forward Ordinance 2023-12 to the December 4, 2023, Regular Meeting for second reading and public hearing, if required.

Background

Article II, Section 4, of the Town's Charter sets the date for the Town's Preliminary Election as the last Tuesday in January when three or more individuals qualify to run for the same seat, and sets the General Election as the third Tuesday in March. The Charter provides an option to align the Town's elections with any other County administered election.

In conjunction with coordination of dates with both Manatee and Sarasota County Supervisor of Elections offices, Ordinance 2023-12 provides for the date of January 30, 2024, for a Preliminary Election (if required) and March 19, 2024, for the General Election in conjunction with the Presidential Preference Election.

Town Code Chapter 36, Elections, provides for establishing early voting in accordance with State law and established procedures. The dates for early voting will be coordinated with the schedules offered by the Supervisor of Elections offices. Ordinance 2023-12 also provides for ballot presentation, advertising, and seeks Commission consideration and confirmation of the Preliminary and General Municipal Election dates, providing for early voting, ballot presentation, and advertising.

Pursuant to Section 166.041, Florida Statutes, a Business Impact Estimate is available for review in the Office of the Town Clerk or on the Town's website at www.longboatkey.org.

Due to the timeframe for qualifying period and the required notice to the Supervisor of Elections offices, first reading of Ordinance 2023-12 is necessary prior to the end of the qualifying period on November 20, 2023. If there are not three or more individuals qualified to run for the same Town Commission seat, there will be no need to hold the Preliminary Election in January. After the qualifying period ends, the Ordinance will be updated as necessary based on the number of qualified candidates per seat, prior to second reading and public hearing at the December 4, 2023, Regular Meeting, if required.

Staff Recommendation

Forward Ordinance 2023-12 to the December 4, 2023, Regular Meeting for second reading and public hearing, if required.

Preliminary and General Election Dates

Background

Pursuant to F.S. Section 166.041(4)(a), effective October 1, 2023, the Town is required to prepare a business impact estimate prior to enacting an ordinance, subject to exemptions noted in the law. Ordinance 2023-12 is proposed to be adopted by the Town on December 4, 2023, and is subject to this new requirement.

Summary of Proposed Ordinance 2023-12

Article II, Section 4, of the Town's Charter sets the date for the Town's Preliminary Election as the last Tuesday in January when three or more individuals qualify to run for the same seat, and sets the General Election as the third Tuesday in March. The Charter provides an option to align the Town's elections with any other County administered election.

In conjunction with coordination of dates with both Manatee and Sarasota County Supervisor of Elections offices, Ordinance 2023-12 provides for the date of January 30, 2024, for a Preliminary Election (if required) and March 19, 2024, for the General Election in conjunction with the Presidential Preference Election.
