Recommended Action

Planning & Zoning Board

Town Code Reference: 33.20 Creation; members

Governing Document: Ordinance 2015-16, adopted 05-18-15 The Planning & Zoning Board shall consist of seven members appointed by the Town Commission. All members must be registered voters and residents of the Town of Longboat Key. No member shall be an elected official or employee of the town. All members must attend a sunshine and public records law class within three months of their appointment (Ord. 2010-09).

No Board member shall serve more than a maximum of three consecutive terms or a maximum of 10 ½ consecutive years. Board members who serve a partial term for a period greater than one year and six months, shall have that partial term counted towards the term limits. Notwithstanding the foregoing, term limits shall be prospective in application and shall be calculated after the effective date of Ordinance 2015-16.

After the initial terms are established, all terms of appointment shall be for a period of three years. The term of appointment shall expire on the second Wednesday of May of the year in which the term is set to expire. Vacancies shall be filled by appointments for the unexpired term.

Code Enforcement Board

Town Code Reference: 33.03 Establishment; members

The CEB shall consist of seven members appointed by the Town Commission. All members must be registered voters and residents of the Town of Longboat Key. The Code Enforcement Board shall, whenever possible, consist of persons experienced in their respective fields as follows: 1) Architect; 2) Businessman; 3) Engineer; 4) General Contractor; 5) Subcontractor; 6) Realtor.

No member shall be an elected official or employee of the town.

All terms of appointment shall be for a period of three years and shall expire on the second Wednesday in May of the year in which the term is set to expire. Appointments to fill any vacancy on the Code Enforcement Board shall be for the remainder of the unexpired term of office. Any member who fails to attend three consecutive scheduled and called regular meetings shall automatically forfeit his appointment, and the Town Commission shall promptly fill the vacancy.

The ZBA shall consist of five members appointed by the Town Commission. All members must be registered voters and residents of the Town of Longboat Key. No member shall be an elected official or employee of the town. All members must attend a Sunshine and Public Records Law class within three months of their appointment. The board shall elect a chairman annually from among its members. The term of office shall be for three years and shall be staggered so that not more than three terms expire within any one year. All terms of office shall expire on the second Wednesday of May of the year in which the term is set to expire.
