A. Town of Longboat Key Legislative Priorities for 2025 Legislative Session

B. FDOT Projects Updates: Broadway and Gulf of Mexico Drive (GMD) Roundabout and the Longboat Pass Bridge

Town Staff will discuss options for funding the high cost of the Gulf of Mexico Drive (SR 789) and Broadway Street Roundabout, review other alternatives discussed for the intersection, and provide an overview of an additional option regarding the Longboat Pass Bridge Replacement Project that requires evaluation.

C. Bay Isles Association Pedestrian Tunnel

The Town has been notified that the Bay Isles Association is contemplating abandoning the pedestrian tunnel connecting the Bay Isles Harborside to and from areas on the west side of Gulf of Mexico Drive (GMD) due to the maintenance costs of the tunnel increasing over time. They have approached the Town and FDOT about taking over ownership and maintenance.
