Subject: Ordinance 2024-09, Amending Chapter 56 of the Town Code

Recommended Action

Adopt Ordinance 2024-09 following second reading and public hearing.

Background

After a disaster, the primary mission of the Town will be to clear public streets, restore governmental services, and protect lives and property. Chapter 56 of the Town Code, Clearing Private Streets, Roads, Roadways, and Private Property, was established to provide a process by which the, Town may evaluate and, if necessary, remove debris from along the curb of privately owned streets, roads, roadways, and other private property in the event of an immediate threat to life, public health, and safety after a significant disaster.

Ordinance 2006-20 established Chapter 56 of the Town Code and included the Debris Management Maps. During the 2024 hurricane season, the Debris Management Maps were reviewed and required modifications were noted and are being incorporated, herein, through Ordinance 2024-09. The modified map, Exhibit A, is attached for your review. The following summarizes the changes that have been made.

Debris Removal Route Map

Page 1 - Pine Street is public, not private.

Page 8 - Bay Isles Road is public, not private.

Additionally, as approved by the Town Commission in February 2019, Ordinance 2024-09 includes capitalization and punctuation modifications throughout the Chapter.

Also, it was noted at the prior commission meeting that the debris maps did not accurately illustrate building footprints and was it possible to have the maps updated. Public Works researched the source of these maps and they were created in 2006 by a company that no longer exists. Therefore, the map building footprints have not been updated.

Staff Recommendation

Adopt Ordinance 2024-09 following second reading and public hearing.
