SUBJECT: FDOT Barrier Island Traffic Study Recommendations

Background

Longboat Key remains an advocate of the Florida Department of Transportation ("FDOT") Barrier Island Traffic Study ("BITS") that has been in progress since July 2017. Town Commissioner Jack Daly serves as the Town's representative on the Barrier Island Study Steering Committee and on the MPO Board. The BITS study is advancing as a threephase study, with Phase 2 recently completed and Phase 3 beginning. As part of the Phase 2 completion, a number of recommendations were produced to improve traffic flow and safety along barrier island routes. The Town of Longboat endorses many of the recommendations, some of which are important recommendations within the City limits. These include, but are not limited to, the following:

Short-Term BITS Recommendations within City limits

- 1. Pedestrian Management on St. Armands Circle-Assignment of pedestrian control officers at the crosswalks on St. Armands Circle during seasonal peak traffic flows to increase capacity and pedestrian safety by platooning on specific legs of the Circle, as previously recommended in a report to FDOT by Sam Schwartz Engineering D.P.C. dated July 14, 2016.
- 2. Elimination of parking spaces with operational conflicts with intersections to improve traffic flow, specifically, along the West leg of St. Armands Circle towards Lido Beach. This has been supported in the past but not implemented. With the opening of the new St. Armands parking garage, our goal is that the City and FDOT would help coordinate this effort with the St Armands Circle Business Association.

Longer Term BITS Priorities

- 1. An additional, flexible lane on future bridge replacements.
- 2. Elevated above-grade pedestrian crossings at key intersections on the U.S. 41 Corridor from Ringling Blvd. to Fruitville Road.

Other Supported Recommendations

- 1. Water Shuttles (mid-term)
- 2. John Ringling Parkway counter-flow (mid-term)

The Town would like to work collaboratively with the City, as well as the FDOT and MPO, on these current and future initiatives.





 - Previously recommended in a report to FDOT by Sam Schwartz Engineering D.P.C. dated July 14, 2016.
- Elimination of certain parking spaces St. Armands Circle
 - At intersections with operational conflicts to improve traffic flow
 - Specifically, along the West leg of St. Armands Circle towards Lido Beach.
 - Previously supported but not implemented.
 - Request support from City and FDOT to help implement this recommendation and coordinate with St Armands Circle Business Association.



BITS Long-Term Recommendations within the City Cont.

Town endorses:

- Additional, flexible lane(s) on future bridge replacements
 - Including Coon Key Bridge
- Elevated above-grade pedestrian crossings
 - At key intersections on the U.S. 41 Corridor from Ringling Blvd. to Fruitville Road



Other BITS Recommendations within the City

Town also endorses:

- Water Shuttles
- John Ringling Parkway Counter-Flow
- Wayfinding and Parking Information/distribution
