Background

Florida Statutes, Section 166.0213, allows the governing body of a municipality to hold joint meetings to receive, discuss, and act upon matters of mutual interest with the governing body of the county at such time and place as shall be prescribed by ordinance or resolution.

In 2003, the Sarasota County School Board and all five local governments entered into an Interlocal Agreement (ILA) for School Facility Planning. Each year the parties to the agreement convene to review and amend the ILA, as needed, and to consider better ways to collaborate regarding school facilities.

Members of the Town Commission will be participating in a Convocation of Governments with the School Board of Sarasota County and four local governmental agencies, including but not limited to the City of North Port, the City of Sarasota, the City of Venice, and the Sarasota County Commission to be held on January 17, 2020, beginning at 9:00 a.m. until conclusion at the Suncoast Technical College, Sarasota Campus, 4748 Beneva Road, Sarasota, Florida.

Resolution 2019-19 provides compliance with Florida Statutes, Section 166.0213 for the Town Commission to participate in the Joint Meeting.

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LONGBOAT KEY, FLORIDA, AUTHORIZING THE LONGBOAT KEY TOWN COMMISSION TO PARTICIPATE IN A SPECIAL JOINT MEETING WITH THE SCHOOL BOARD OF SARASOTA COUNTY AND FOUR ADDITIONAL GOVERNMENTAL AGENCIES TO RECEIVE, DISCUSS, AND ACT UPON MATTERS OF MUTUAL INTEREST; PROVIDING AN EFFECTIVE DATE.
